**Not all power of attorney documents are created the same.** Powers of attorney must explicitly state each and every thing the person can do. *The five most common powers we find routinely missing in power of attorney documents are:*

- The ability to create trusts, including irrevocable trusts.
- The ability to make unlimited gifts, including making gifts to the power of attorney.
- The ability to manage tax qualified plans such as IRA and 401k plans.
- The ability to convey the "homestead" including the ability to waive constitutional homestead interest.
- The provision for an alternate power of attorney.

And power of attorney documents should be newer than five years old.

The National Institutes of Health has this information about people who have brain changes, but still have normal function.

**"Non-demented with Alzheimer's neuropathology"** (NDAN) describes people who have the characteristic brain changes of Alzheimer's (like amyloid plaques and tau tangles) but remain cognitively normal, suggesting they possess powerful cognitive resilience through mechanisms like synaptic remodeling, increased neurogenesis, and unique protein profiles that protect neurons from damage.

**Presence of AD Pathology:** They exhibit significant plaques and tangles (NFTs) in their brains, similar to those with symptomatic Alzheimer's disease (AD). But, despite the pathology, they maintain normal cognitive function, passing standard tests for memory and thinking. This hypothesis leads to two predictions:

1. Aged individuals with more education are expected to demonstrate less cognitive impairment when compared to people with less education
2. Individuals with higher socioeconomic status are able to withstand the typical AD pathology for extended time due to unknown mechanisms.

Another possibility is that more years of education allow people to make better choices regarding their lifestyle, thus leading to better overall health and decreased risks for dementia.

### IMPORTANT:

Please have your veteran **register** his or her **DD-214** at their COUNTY courthouse. This will save a lot of time when you may have to find and access this document for many reasons to include eligibility for: widow benefits, burial benefits, property tax exemptions, medical coverage, PACT Act, dental insurance programs, and nursing home care.

→ **The new Florida Law for all medical settings to identify common risk factors for Venous Thrombosis (Blood Clots) is so important.** There are many risk factors to include: recent surgery, trauma from an accident, cancer treatments, injury to a vein, family history, confinement to bed or wheelchair, smoking, diabetes, heart or lung conditions and COVID-19.
