Alzheimer's disease is a leading cause of death in the United States. It's important to distinguish the facts from the myths about Alzheimer's. **Common myths include:**

- Alzheimer's and dementia are the same thing. People often use the terms "Alzheimer's disease" and "dementia" interchangeably, but there is a difference. Dementia refers to impaired memory, thinking, reasoning, and behavior, and Alzheimer's is just one type of dementia.

 I will develop Alzheimer's if my parent has it. A person's chance of developing Alzheimer's is higher if they have certain genetic variants passed down from a parent. However, just because a biological parent has Alzheimer's does not mean that their children will develop it.
- Alzheimer's disease symptoms are normal as we get older. Many people become more forgetful as they age, and some forgetfulness is normal. However, the signs and symptoms of Alzheimer's are not a normal part of aging. For more info, visit: https://www.nia.nih.gov/health/alzheimers

Required Minimum Distributions (RMDs) are the minimum amounts a retirement plan account owner must take out each year. RMDs begin when a person reaches either age 72, (70½ if they reached this age before January 1, 2020), or the year in which a person retires (if after age 72). It is the responsibility of each retiree to take out the correct RMD from their retirement account each year. If a retiree does not do so, they can face penalties. Furthermore, upon a person's death, there are special rules regarding how the remaining funds must be distributed to beneficiaries. 
FDA APPROVES <u>DaTscan</u> for DEMENTIA with LEWY BODIES

GE Healthcare recently announced the U.S. Food and Drug Administration (FDA) granted marketing approval for its imaging agent, DaTscan, for use in people with suspected dementia with Lewy bodies (DLB). DaTscan is an agent used during imaging scan called single photon emission computed tomography or SPECT and can help differentiate between DLB, Alzheimer's disease and other forms of dementia. DLB can mimic Alzheimer's disease and is missed as a diagnosis in up to 70% of dementia cases. Yet, LEWY BODY affects one in five living people living with dementia, making it the second most common type of progressive dementia after Alzheimer's disease. DaTscan has been approved by the European Union for years for DLB, but until now had been previously approved by the FDA to differentiate between essential tremor and Parkinson's disease.
