DURABLE POWER OF ATTORNEY

Lots and lots of discussion about the new Durable Power of Attorney going on at support groups. Does yours have these five things?

1. The ability to sell or transfer property to oneself or self-enrichment. The ability to sell or transfer the homestead.
2. The ability to change the character of, sell or transfer IRA's.
3. The ability to create an irrevocable trust or Income Trust in order to qualify the client for Medicaid.
4. The ability to surrender or assign ownership and change beneficiaries of life insurance policies.
5. It is also advisable that the ability to negotiate CD's, stock certificates and other financial vehicles is documented in the DPOA.

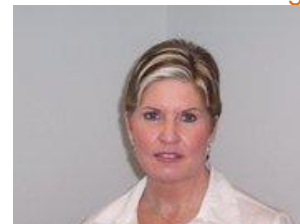
